Cicero Interview: Fiona McAllister

Introduction to Fiona McAllister, partner at Mundays in London.

1- How would you describe your business?

Mundays LLP works primarily with small and medium-sized enterprises ("SMEs") providing support in both the private and business lives of our clients. 3- What is happening in the legal industry in England at the moment?

At the moment it is very much business as usual, although there is a lot of talk about what the future might hold. In fact we currently have not seen any material change following the referendum vote by the United Kingdom to exit from the European Union. It is fair to say that most lawyers are not expecting a great deal of change to our key regulations on business or health and safety. In the UK we are very compliant on the whole with all regulations issued whether by our own Government or by Europe. So whilst there has been much complaint about the complexity of regulations from Europe, we are unlikely to tear up all the rules. That is just not British! Just last year we celebrated the 800th anniversary of the "Magna Carta" seen by many as the first seed of democracy in Western Europe. It will certainly be important going forward for the legal profession to keep a watchful eye on the politicians to protect our democratic principles, for many a key issue in the referendum vote.

4- You have been involved with Cicero for some time and you are also a board member. Why?

From a business perspective I think it is crucial to be a member of a good network from which you can seek support or refer clients as so much of our business has an international element reflecting that of our clients on both the corporate and private side of the business. This can create interesting opportunities, on the one hand, and difficult conflict-of-laws questions, on the other. The advantage of the Cicero network (of which I am a huge fan), is that we do get to know representatives of member firms at our conferences. Networking helps to get to the point at which you can feel very comfortable not only with the quality of our work which has to be a given but that Cicero members will be able to deal with your clients in the efficient and timely manner that you would wish.

Russian athletes represented by GvW Graf von Westphalen in defending against exclusion from the Paralympics in Rio.

Five Russian athletes have now filed constitutional appeals with the German Constitutional Court (Bundesverfassungsgericht) against their exclusion from the Paralympics Games 2016 in Rio de Janeiro. GvW Graf von Westphalen filed the appeals for the athletes in Karlsruhe.

The International Paralympic Committee (IPC) had excluded the Russian Paralympic Committee (RPC) and, thus, all Russian para-athletes at the same time on the basis of systematic Russian government. The Committee defended itself before the International Sports Court of Arbitration (CAS) as well as the Swiss Federal Court, and the athletes defended themselves against the exclusion before the District Court (Landgericht) Bonn and the Courts of Appeals (Oberlandesgerichte) in Cologne and Düsseldorf.

Although the application by the para-athletes for a temporary injunction against the refusal to admit them to the Paralympic Games did not succeed before the German Constitutional Court, the Karlsruhe constitutional judges made it clear in the reasons stated for their order of 15 September 2016 (1 BvQ 38/16) that a constitutional appeal that could still be filed was by no means obviously inadmissible or obviously without merit. The court stated that it was necessary to take into account numerous individual circumstances and difficult legal issues, especially relating to the relationship of individual athletes to the world organization IPC and potential influence of national antitrust law on these decisions.

In light of this background, GvW has now also filed the constitutional appeals. The brief in support of the constitutional appeal dated 10 October 2016 especially argues that the individual fundamental rights of the para-athletes were not adequately taken into account. This is argued to especially apply to the extent that the Düsseldorf Court of Appeals raised a general suspicion in its decision against all Russian athletes that they had engaged in doping. The brief also argues that no legal remedy was granted within a reasonable period of time.

GvW Graf von Westphalen represented the RPC and the Russian athletes in all proceedings before the German courts through Felix Prozorov-Bastians (head of the Russian Desk, lead attorney), Dr. Julia Christine Pohl (all litigation), Prof. Dr. Christian Winterhoff, Dr. Jan Felix Sturm (both constitutional law), Dr. Reinhard Höß (sports law) as well as Christian Kusulis (antitrust law).

Studio Legale Afferni Crispo & C. advises consumer association in legal proceedings before the European Court of Justice concerning a possible restriction of competition in the pharmaceutical sector.

The Italian Council of State, the highest administrative court in Italy, recently referred a case to the Court of Justice of the European Union (CJEU) dealing with a possible restriction of competition in the pharmaceutical sector.

The case had reached the Council of State as an appeal against a ruling of the Administrative Tribunal for the Lazio Region, which had confirmed a decision of the Italian Antitrust Authority.

According to the Italian Antitrust Authority, the pharmaceutical companies Hoffmann-La Roche and Novartis had put in place, contrary to Article 101 TFEU, a horizontal agreement restricting competition and designed to achieve an artificial differentiation of the medicinal products Avastin and Lucentis by manipulating the perception of the risks

involved in the off-label use of Avastin in the field of ophthalmology. The Italian Competition Authority found that that agreement was concluded with the objective of unlawfully maximising the income from those medicinal products and had a direct effect on the balance of health expenditure.

The questions referred to the CJEU focus on issues such as:

- 1) the proper construction of Article 101 of the Treaty on the Functioning of the European Union (TFEU) in a case involving the possible restriction of competition between the parties to a licensing agreement;
- 2) the possibility for a National Antitrust Authority to define the relevant market autonomously *vis-à-vis* the content of marketing authorisations for medicinal products granted by the competent pharmaceutical regulatory authorities;
- 1) the interchangeable nature, under Article 101 TFEU, of a medicinal product used off-label and a medicinal product that has received a marketing authorisation in respect of the same therapeutic indications;
- 2) whether Article 101 TFEU requires, for the purposes of defining the relevant market, to establish, in addition to the essential fungibility of pharmaceutical products on the demand side, whether or not those products have been supplied on the market in accordance with the regulatory framework concerning the marketing of medicinal products;
- 3) finally, whether a concerted practice intended to emphasise that a medicinal product is less safe or less effective can be regarded as intended to restrict competition, when the idea that that product is less effective or less safe, although not supported by reliable scientific evidence, cannot, in the light of the level of scientific knowledge available at the time of the events in question, be indisputably excluded.

Studio Legale Afferni Crispo & C. has advised one of the consumer associations that are parties to this proceeding since the phase that took place before the Italian Antitrust Authority.

Garfield Bennett

Garfield-Bennett English Solicitors ("GBES") succeeds in wresting trusteeship from renegade Panamanian trustee.

A recent string of judgments in Stock v Pantrust International SA sees Jersey's Royal Court flexing its jurisdictional muscles in swiftly dealing with a dispute concerning two Jersey trusts.

The beneficiary of two discretionary trusts approached GBES with a view to removing the trustee and having G.B. Trustees Limited (a Jersey-regulated entity and part of the Garfield-Bennett group) appointed in the place of the Panamanian trustee as well as having purported changes to the proper law of the trusts declared invalid.

The longstanding relationship between the settlor of the trusts and one of the directors of the Panamanian trustee had broken down to such an extent that the director now claimed that the settlor controlled and benefitted from the assets of the trusts which he claimed to be sham arrangements.

GBES worked with Panamanian Counsel to register a complaint with the Panamanian regulator as to the trustee's handling of the affairs of the trusts in 2014 which resulted in the first cancellation of a trust company's licence in Panama.

The refusal of the trustee to comply with the Panamanian regulator's order resulted in an application before the Royal Court for a transfer of trusteeship. The sequence of judgments removed the Panamanian trustee. It also declared a change of proper law which had purportedly occurred in 2007 to be invalid.

The judgements demonstrate how matters may be dealt with expeditiously by the Jersey courts where the circumstances require it. It further shows that relationships formed in Jersey, and governed by its laws, will not be lightly surrendered despite executed documentation to the contrary. Proper consideration will be given to the documentation and surrounding factual matrix leading to well-reasoned decisions provided in a relatively short space of time (in this instance, eleven months from start to finish).
